JUSTICE POONAM A. BAMBA, FORMER JUDGE, DELHI HIGH COURT



Justice Poonam A. Bamba was born on 01st September, 1961 at Delhi. She did her schooling from Delhi. Graduated with Honours in Botany from Hansraj College, Delhi University. She did her LL.B. and LL.M. from Faculty of Law, Delhi University. She holds Diploma in Administrative Law from the Indian Law Institute, New Delhi.

She Practiced as an advocate in Delhi District Courts and High Court of Delhi, worked with Banks- Punjab National Bank and Central Bank of India, as Law Officer/Deputy Chief Officer (Law) and with Securities and Exchange Board of India (SEBI), Mumbai, as Division Chief (Legal) and Joint Legal Advisor. She also represented these banks and SEBI before various courts of India and also the Securities Appellate Tribunal, Mumbai.

Justice Poonam A. Bamba is a Trained Mediator.

She attended various national and international Training Programmes, including a month long Programme on Capital Market, at Baruch College, New York, USA and a Programme on Investigation and Enforcement of Securities Laws at Securities and Exchange Commission (SEC), Washington, USA; and also attended various conferences of International Organization of Securities Commissions (IOSCO).

Justice Bamba joined Delhi Higher Judicial Service on 05th December, 2002. During her tenure spanning over a period of 19 years approximately, she presided over various jurisdictions viz. Sessions Courts, Special Judge, CBI, at Patiala House Courts, NIA Court, Matrimonial Court, Family Court as Judge/Principal Judge, Land Acquisition Court, Appellate Court under Public Premises (Eviction of Unauthorized Occupants) Act, 1971, Food Safety Appellate Tribunal.

She remained posted as District & Sessions Judge in different districts for a period of about five years i.e., at South East District, Saket at New Delhi District at Patiala House Courts and as Principal District & Sessions Judge, at South District, Saket Courts Complex.

Justice Bamba was elevated as a Permanent Judge of High Court of Delhi on 28th March, 2022.

She is the Member of Delhi International Arbitration Centre.

Justice Bamba was appointed as Chairperson, Police Complaints Authority on 16.10.2023.

She has authored four books viz. Perfect Marriage- Not a Mirage, How to Save your Marriage (2nd Edition), 'Temple of Justice- A School of Life', 'Parents at War- Custody Battles in Indian Courts' and a Coffee table book, "Patiala House: Palace To Seat of Justice". She has also published Articles on various subjects in Journals of Delhi Judicial Academy, National Stock Exchange, and that of Central Bank of India.

Justice Bamba has been visiting as Guest Faculty/Resource Person at National Judicial Academy, Bhopal, Delhi Judicial Academy, Dwarka, Delhi, UTI Institute of Capital Markets, Mumbai, Training Institute, Stock Holding Corporation of India, Mumbai, Northern India Bankers Staff Training College, Delhi and Zonal Staff Training College, Central Bank of India.

She as a sports person, had earned the title of the 'Best Athlete' of Law Faculty, University of Delhi in the year 1983.

Justice Bamba is an avid reader and is also a nature enthusiast.
